WATER RATE INFO

On your next water bill you will notice a change in rate structure.

Several months ago the Village Board directed the Village Engineer to assess the Water Supply System. In order to advance the necessary upgrades, the village is moving forward with a multi-layered approach to increase revenues. This includes increasing water rates and applying for grants to replace aging infrastructure, with the ultimate goal to replace all residential water meters. The main goal of the Village Board of Trustees and employees of the Village is to continue offering a safe, quality product.

Winter will be here before we know it!

Every street needs to be plowed from curb-to-curb. Please ensure all garbage and recycling containers are **NOT** in the road.

ON GARBAGE DAY, PUT CONTAINERS IN THE DRIVEWAY, OUT OF THE WAY OF SNOW PLOWS.

FALL BRUSH AND LEAF PICK UP

The Street Department will pick up **BAGGED** leaves & brush every **MONDAY & THURSDAY** during the months of **SEPTEMBER & OCTOBER**.

Leaves must be in **BIO-DEGRADABLE PAPER BAGS**. Leaves left in a pile on the side of the road and **NOT** in a bag will not be picked up.

BRUSH must be in manageable sections, no longer than 5ft. **LOT CLEARINGS, TREES OR TREE STUMPS** are not collected.

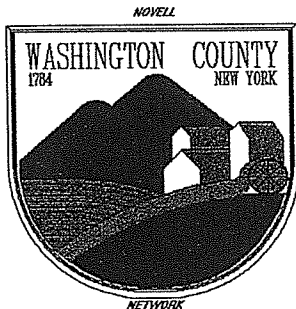
These items which can be brought to the site for free, proper disposal include:

- Pesticides, Fertilizers, Pool & Household Chemicals/Cleaners
- Oil-based Paints, Spray Cans
- Paint Thinner, Stripper, & Solvents
- Batteries (lead acid, rechargeable-NO ALKALINE)
- Oil, Gasoline, Kerosene, Antifreeze
- Mercury (thermometers, thermostats, metal)
- Propane Tanks & Cylinders (full or empty)

Items that will not be accepted include:

- Tires
- Electronic Waste
- Latex Paint (for disposal remove lid and dry contents and dispose with regular refuse disposal)
- Medical or Infectious Waste
- DEA Controlled Substances
- Explosives or Ordnance
- Radioactive Compounds
- Compressed Gas cylinders
- Type A or B Organic Peroxides

Residents will be required to provide proof of residency within Washington County, Driver's License, Tax Bill, and/or recent Utility Bill. Residents will be required to certify that wastes were generated by households in Washington County and will be limited to dropping off for disposal materials listed above and limited to the following quantities two hundred (200) pounds of solids and two hundred (200) gallons of liquid total.
