# PUBLIC HEARING ON LOCAL LAW #3 PUBLIC PARKING

The Village of Fort Edward Board of Trustees has determined that it is in the public interest to adopt a local law amending the Village's Vehicle and Traffic local law to amend certain no parking areas and other amendments.

Mayor Traver re-opened the public hearing which was tabled from last month's public hearing on July 2, 2018 @ 6:30. Mayor highlighted some specific streets and what the proposed changes would be. The topic focused on Mechanic Street and Seminary Street.

Village attorney reviewed the proposed signs which state "parking prohibited" between 37-39 Mechanic Street, which is Pickett, south.

# PUBLIC COMMENTS

#### Ginny Henry 42 Mechanic Street

Ginny asked about the big trucks which come down Pickett Drive. Ginny has a concern regarding this and asked if there was another route they could take, i.e garbage haulers, construction vehicles, etc. Ginny feels that big, heavy trucks be prohibited from driving down Pickett Drive and allow them to only use Division Street. Ginny also voiced her concern regarding family, friends coming to visit the homes of residents on Mechanic. Where should they park?

## **Board Discussion**

E. Carpenter	Unfortunately, we cannot stop the garbage haulers from coming out Pickett Drive. We also cannot stop big delivery trucks, i.e Lowes, or any big business from using Pickett Dr.	
J Boucher	Large trucks need to use the easiest route.	
Mayor	There is room for parking on Seminary Street, 25ft past the corner of Seminary and Mechanic.	
P. Williams	41 Mechanic, landlord has to provide 1 $\frac{1}{2}$ spaces for parking for tenants. If this is not allowed by the landlord, it needs to be addressed by Code Enforcement and a violation needs to be sent.	
Mayor	Where do you park in the winter months with the winter parking law?	
Applicant	Ginny explained that Lucy Baldwin lets her park in her driveway in the winter months during the winter	
P. Perry	parking restrictions. Addressed some wording to the attorney on the local law and asked if it could be re-written	
Attorney	Correcting the wording of a specific paragraph.
