Resolution 9 of 2023-2024 TO ENTER INTO A CONTRACT WITH C.T. MALE ASSOCIATES D.P.C FOR RESTORE NY ROUND 7 GRANT ADMINISTRATION SERVICES

WHEREAS, the Village of Fort Edward is has been awarded \$500,000 in Grant funding under Round 7 of the Restore NY Communities Initiative administered by Empire State Development Corporation (ESDC), and

WHEREAS, the Board of Trustees has determined that the Village is interested in professional assistance with respect to grant administration and coordination services for the Restore NY Round 7 Grant Award in conjunction with local staff and administrative capacity, and

WHEREAS, the Board of Trustees has considered a proposal submitted by C.T. Male Associates D.P.C. for grant administration services and advisory and coordination assistance as needed to facilitate implementation of the Restore NY Round 7 Grant Award, and

WHEREAS, the Board of Trustees has considered said proposal to consist of reasonable costs and associated work scope tasks determined to be helpful to the Village to ensure proper implementation of the Restore NY Round 7 Grant Award in accordance with local and State policies and regulations, and

WHEREAS, the Village Attorney has reviewed said proposal and draft Contract Agreement and determined those documents conform to current Village policies and contract provisions, now therefore,

BE IT RESOLVED, the Village intends to administer the Restore NY Grant in compliance with all applicable rules and regulations established by ESDC; and,

BE IT FURTHER RESOLVED, the Board of Trustees at its regular meeting dated September 5, 2023 authorizes the Mayor to enter into a Contract with C.T. Male Associates D.P.C. for certain Grant Administration Services with respect to the Village's Restore NY Round 7 Grant Award.

OTHER BUSINESS

Water Project – Due to the water project being on hold, the village, with the help of Jim Thatcher, has applied for a CDBG grant to continue the project with replacement of water lines on Cooper, Prospect and Grove Streets in the village. Currently, the village owes the short-term financing to EFC in the amount of \$138,502.20 in engineering costs with LaBella. The village also owes LaBella an additional \$81,676.70 that was not distributed through financing. Attorney Fuller will make a call to EFC to discuss where we will go from here. Mayor Traver did mention that when the village does move forward with the project, we should not have to go through the engineering process again.

Jim Thatcher mentioned that the engineering report was submitted with the CDBG grant application which fills in the gap. Attorney Fuller advised the board that if they walk away from this project, it cannot be listed again. The village must be careful as to how to proceed with this project for the future. If the village withdrawals, it cannot go back. Mayor Traver agrees that it is not wise right now to jump into a \$355 k/year payment. Trustee Boucher commented that we just got some relief by making our last payment on the water plant in July.

- Mullen Park There was a proposal submitted by Hour Electric for new lighting at the park. Steve from Hour had mentioned it may be a good idea to replace them with LED. The proposal gave three different options. There were some questions regarding the proposal. Will get confirmation back from Hour Electric before deciding. <u>Courts at Mullen Park</u>: the board asked if there was any update to this project from Services Unlimited. They are playing catch up with all the rain this summer. Janelle will follow up to get some dates on the paving project as well as the courts at the park, hopefully getting some answers for the next meeting.
- Streetlights within the village Jeanie Mullen asked about some lights humming as she walks by. The mayor asked Jeff to get another guy and assess the lights to see which ones need new bulbs and which ones have sensor issues we can address. The mayor also asked if the globes could be cleaned.
- Drifting Ridge The village board received some documentation from the Town assessor regarding the vacant lots in Drifting Ridge. Larry Clute is developing the rest of the lots and changing it to a "park" like Shelly Park. This changes the assessment, increasing it each time a home is put on a lot.
- Updates from Trustee Carpenter Trustee Carpenter mentioned that the reservoir fence is complete. Zarro Fence will be moving on to the fence on Reservoir Road. The brush around the water tower on Burgoyne Ave was cleaned up as well. 31 rangers came to the Visitors Center and purchased dinner at the Idle Hour Club. This is becoming a national event.
- Annex Building Trustee Williams asked about the survey on the annex property. Attorney Fuller sent out bids for proposals and one came back at \$6,400. There is a deed from the early 1900's that includes the house and the garage on the 1-acre piece.
- WWIDA- Mayor Traver had a meeting with the IDA regarding the property to be developed. Mayor Traver said the idea of a water tower over there floated around the meeting stating that it would be a lesser draw on our system. Putting a storage tank on site would be beneficial. The idea of the water tower in the Knolls was also mentioned. The water service is partially in the village. A non-village user agreement can be drafted. The idea of using the tower was not dismissed when discussed at the meeting. The tower is twice as big as they need but if it works, they will consider it. "It would be nice for the tower to get some use as it has been sitting a long time unused", Mayor Traver added.
- Sheriff's Report The mayor reviewed the report sent in by Sheriff Murphy and commented that it has been very busy. He has heard from many that they are seeing the sheriff's around, and it is good to see. There are many DWI's and drug arrests. The mayor mentioned that the sheriff's department has 4 officers out of field training now so we will be seeing them around.
- Kayak launch There is a joint application for the Army Corp and DEC which the village must fill out and submit prior to the project. Erin Teta from NYS Canals asked for the application to be submitted as soon as possible. Janelle and the mayor will review together.
- > Trees Mike Dickinson asked if the board wants to proceed with an inventory of trees as he would

like to start. Mike also asked what the reasoning was for doing an inventory. The mayor stated that we need to do it for budgetary purposes. Mike asked if we had a village ordinance for trees and "if not, you should", he stated. The inventory will start after Locktoberfest, which is 10/14/2023. Trustee Williams agrees that the village should get something in place for the future and set up a policy located in the ordinance. The policy should also state not to let the power company hire for tree trimming in the future. They only focus on keeping the tree away from the wires and have no regard for the health of the trees. Mike also said the village board should request documentation if a resident is going to be planting a tree. Frank Burkhardt asked the village board what an acceptable tree is to plant as a homeowner. Mayor Traver said they can sit down and discuss what trees are dangerous after the inventory is complete and work on budgeting so many trees each fiscal year. Trustee Williams said that there are a lot of trees that impact our sidewalks and water shut offs. Mayor will work with Attorney Fuller to put together an ordinance for trees.

- Amphitheater Mayor Traver said they are narrowing down the project with Joe Roblee. Loren Sullivan, a long time Fort Edward resident and graduate would like to donate \$10,000.00 to the project. He will donate to the Canal Street Marketplace. Trustee Williams stated they will store the funds in the grant account. Still waiting for an estimate from V&H, and the mayor suggested getting some product like the concrete donated. Once they know what they need for concrete, they can get a quote on the project. Mayor Traver is going to email a couple of dates that work to have a meeting to go over the design, pitch of roof, etc. The amphitheater will face the water. Should we have more funds come in for the project, they will go to the marketplace grant fund. The market will then donate the structure to the village. There is no prevailing wage for the project either.
- Code Enforcement Dave sent out another round of letters to business owners on Broadway as well as any homes on Broadway to clean the front of their buildings. Dave mentioned that he has received many complaints regarding the motel at 215 Broadway. Attorney Fuller will discuss it with Dave later.
- 138-140 Broadway Mayor Traver asked Jeff Caprood from the DPW if we could get the front of 138-140 Broadway cleaned. Jeff mentioned using the water from the sweeper to clean the fronts.
- Case Street Trustee Boucher mentioned that Case Street now has pylons in the middle of the road however he suggested "do not enter" signs being installed coming west down Case which is against the one way. This may deter traffic from going the wrong way down Case Street. Trustee Williams also stated that law enforcement will take care of violations.

A motion to executive session was made by **Trustee Carpenter**, seconded by **Trustee Boucher**. All ayes. Motion Carried.
