- To establish a clear framework for the upcoming project phase, focusing on enhancing user engagement and improving operational efficiency through strategic planning and collaboration among stakeholders.
- Establish a moratorium on solid waste projects to assess environmental impacts and enhance community safety.
- Engage with external legal counsel to ensure comprehensive understanding and compliance with regulations.
- To address community concerns regarding environmental safety and regulatory compliance related to waste processing in the village, ensuring transparency and accountability in operations.

Decisions Made:

- Agreed to hold a public hearing for the proposed local act of moratorium on PFAS treatment.
- Decided to move forward with securing the annex building and addressing immediate safety concerns.
- Established a plan to meet with attorneys and board members to clarify grant expectations and project requirements.
- Committed to exploring additional grant opportunities for engineering and planning needs.
- Agreed to hold public hearings to discuss the moratorium and gather community feedback.
- Decided to engage with external legal counsel to provide additional expertise on solid waste legislation.
- Confirmed that the moratorium will not retroactively affect projects already in progress unless legally applicable.
- The village board will investigate the waste processing operations and consult with DEC regarding compliance.
- A commitment to improve communication with the community regarding environmental safety issues.
- Future meetings will include discussions on the findings and actions taken to address community concerns.

RESOLUTION INTRODUCING PROPOSED LOCAL LAW ENACTING A MORATORIUM ON THE TREATMENT, TREATMENT TESTING, DISPOSAL, STORAGE OR DEPOSIT OF MEDIA CONTAMINATED WITH PERFLUOROALKYL AND POLYFLUOROALKYL SUBSTANCES (PFAS) IN THE VILLAGE OF FORT EDWARD

WHEREAS, pursuant to the New York State Constitution, including but not limited to Article 1, section 19 thereof; the provisions of the New York Municipal Home Rule Law; the provisions of the Statute of Local Governments; the relevant provisions of the Village Law of the State of New York; the laws of the Village of Fort Edward and the general police power vested with the Board of Trustees (the "Board") of the Village of Fort Edward (the "Village"), the Board has the authority to adopt local laws to protect the health, safety and welfare of its citizens; and

WHEREAS, the Board finds and determines that, without proper regulation thereof, the treatment, treatment testing, disposal, storage or deposit of PFAS contaminated media or materials at property in the Village has the potential to negatively and adversely affect the citizens of the Village; and

WHEREAS, in an effort to protect the health and safety of the citizens of the Village, the Board hereby determines that a review of Village Code with regard to the regulation of the treatment, treatment testing, disposal, storage or deposit of PFAS contaminated media or materials at property in the Village is necessary and proper; and

WHEREAS, in order to provide the Board with sufficient time to review, study, analyze and if necessary revise, the Code of the Village with regard to the regulation of the treatment, treatment testing, disposal, storage or deposit of PFAS contaminated media or materials at property in the Village, it is in the best interests of the citizens of the Village to impose a moratorium on the approval of services involving the treatment, treatment testing, disposal, storage or deposit, storage or deposit of PFAS contaminated media or materials at property in the Village; and

WHEREAS, a proposed Local Law imposing a moratorium on the treatment, treatment testing, disposal, storage or deposit of PFAS contaminated media or materials at property in the Village has been presented to the Board; and

WHEREAS, the adoption of a moratorium constitutes a Type II Action under the State Environmental Quality Review Act pursuant to 6 NYCRR section 617.5(c)(36), and as such, this action is not subject to further review under the State Environmental Quality Review Act; and

WHEREAS, the Board wishes to hold a public hearing on the proposed adoption of a local law providing for a moratorium on the treatment, treatment testing, disposal, storage or deposit of PFAS contaminated media or materials at property in the Village, and to provide for the proper referrals of said local law.

NOW, THEREFORE BE IT:

RESOLVED, that he proposed local law enacting a moratorium on the treatment, treatment testing, disposal, storage or deposit of PFAS contaminated media or materials at property in the Village is local law is hereby accepted for introduction to the Board; and be it further

RESOLVED, that a public hearing shall be scheduled for the consideration of the proposed local law to be held by the Board on January ____, 2025 at 6:00 p.m.; and be it further

RESOLVED, that the Village Clerk is directed to post and publish a notice of said public hearing in *The Post Star* at least ten (10) days before the hearing; and be it further

RESOLVED, that the Village Clerk is directed to forward the proposed local law to the appropriate bodies as provided for in Village Law Section 7-706; and be it further

RESOLVED, that the Village Clerk is directed to forward this proposed local law to the Washington County Planning Board in accordance with Section 239-m of the General Municipal Law; and be it further

RESOLVED, that this action constitutes a Type II Action under the State Environmental Quality Review Act pursuant to 6 NYCRR section 617.5(c)(36) and requires no further review under the State Environmental Quality Review Act; and be it further

RESOLVED, that this resolution shall take effect immediately.
