Public Comment Period

Rick Doty – Case Street

Rick wanted to point out the pothole on McIntyre Street on the right side going North. He is hoping it can be fixed as it is doing a lot of damage to vehicles tires.

Rick also wanted to inform the village that National Grid as they are replacing the gas lines noticed that the lines are only 18” down and not 24” down as they should be. This is the entire length of Case Street.

Mr. Weber – Ye Old Fort Diner

Mr. Weber approached the board table and stated the following:

“27 years I have been in business at the Old Fort Diner. I have been highly involved in Fort Edward and have given back plenty, but I won’t get into that. For two years, the food wagons have been operating for free against my business. My expenses, just to give you an idea are \$4800 liability for the diner, \$3300 liability for the deli, 12 people on my payroll at \$4500 a week. You allow food wagons to operate for just 67 cents per day while I spend thousands. I spend \$2000 each winter just to have my parking lot plowed. I pay more for my water and sewer bills than the food wagons do to operate in the village. What is fair? The board is trying to destroy me. I sat on the bench the other day and watched that food wagon makes \$400 in just 20 minutes. What is their payroll? What is their sales tax bill? There are places for food wagons and it’s not fair. Follow Glens Falls, they have a policy that you cannot set up a food truck 250 ft within another food establishment. Also, to let you know, I have 5 employees who live in the village. I am asking youwhat is fair? The board is prejudice against me”.

Amanda Durkee – Seminary Street

Amanda asked what roads were slotted to get fixed because at the bottom of her driveway in the road, it is pretty bad and should be fixed.

Secondly, Amanda stated that she is noticing a rise in homelessness in Fort Edward and wants to know what the village representatives are doing to help. The mayor said that it should be reported with the sheriff’s office as well as our office to ensure that they are not just being booted off property, however they are in connection with social services to get the help they need.

Jessica Donnelly – Hudson Falls resident

Jessica wanted to inform the board and the residents who were in attendance that there is a public meeting for Wheelabrator in Hudson Falls on 4/16/25 at 6:00 p.m. She informed the room that after investigating the company further, 87% of their burning is coming in from Canada, Ohio and they are also burning sewer sludge from the city of Glens Falls. The group is advocating for a non-renewal of their permit which renewal is coming up.

The mayor informed the board that Mr. Rourke wants to give a piece of land, which is very small to the village which separates the right of way from Drifting Ridge and King Edward Knolls. The village has a utility right of way for both neighborhoods, but they do not connect due to the small piece which Rourke owns. The village attorney, Matt Fuller, will reach out to Rourke to get the ball rolling to get this accomplished.

**Water Project** - through CDBG is complete, however the road will be paved completely from curb to curb after the village goes out to bid on it. Bellamy may want to quote for this as well, which is the company responsible for the entire project of new water lines on Cooper, Prospect and Grove Streets.

**Water Tower Project** - has a large expense from our engineer, La Bella and the village must recoup those funds from EFC. The attorney and La Bella will work to get a disbursement in the works for the amount that has been spent on engineering already.

**Canalside project** – This project has a water demand at the location which there is a potential company interested which will need approximately 200,000 gallons of water per day. They will need a fire tower on site, and it was recommended that they have a potable tank. Also, the village could upsize the new water tower on Burgoyne Ave. All funds to upgrade or any expenses to make this happen will not be on the village. The mayor asked Rob Martin about having enough volume with the natural gas. He did say that ESMI would be able to run one more burner which uses 45 million BTU's.

**Peddling Local Law** – The village is underway on revamping the local law for Peddling and Soliciting in the village. A draft was final for the board move forward with a public hearing.

**Kyle Cozzens – East Street**

Kyle revisited the discussion from three years ago when an engineering firm came to a meeting to discuss a project to extend the NYS trail through the old canal which would include fixing or replacing the old bridge at the end of Canal Street. This project is a 1 million dollar project. This could eventually become a long term project and goal.

A motion to set a public hearing for the updated version of the Peddling and Soliciting local law was made by Trustee **Cutler**, seconded by Trustee **Carpenter**. The public hearing will be held at **6:30 p.m. on Monday, May 5<sup>th</sup>, 2025**.
