SIDEWALKS

SECTION 278.10a of the Village of Fort Edward Code

All sidewalks shall be kept free of ice and snow within 5 hours of each storm.



Parking on sidewalks is PROHIBITED!!

Bagged leaves and brush will continue to be picked up until **Nov 15**th or weather permitting. Brush *MUST* be from clean up or storms. Brush piles should be no bigger than 4-6 ft in length and manageable for pick up. **WE WILL NOT PICK UP any tree removal!**

Every street needs to be plowed from <u>curb-to-curb</u>. Please ensure all garbage and recycling containers are **NOT** in the road and are put out the night before, after 6:00 p.m.

ON GARBAGE DAY, PUT CONTAINERS IN THE DRIVEWAY, OUT OF THE WAY OF SNOWPLOWS AND RETURN TO PROPERTY AFTER COLLECTION. DO NOT LEAVE IN ROAD!

PARKING

Parking will be **PROHIBITED** on all village streets between the hours of **3:00AM-6:00AM** from **NOVEMBER 15, 2024, UNTIL APRIL 15, 2025,** pursuant to *Section 39 of the Village Traffic Code. Violators will be towed.*

Parking on sidewalks is prohibited.

DOGS

Section 114-5 of the Village of Fort Edward Code It shall be unlawful for any owner of a dog to:

- 1. Allow their dog to damage or destroy property of any kind.
- 2. Allow their dog to bark, whine, howl or make other frequent and continual noises so as to unreasonably disturb the peace of any person.
- 3. Allow their dog to defecate on public lands, streets, highways or other public places without immediately removing such defecation.

VIOLATORS will be fined.
